

## **INFORMATION ON PROCESSING PERSONAL DATA IN THE CONTEXT OF PUBLICATION ON THE WEB SITE OF THE CONTROLLER**

### **EDIFICATION REGARDING RIGHTS CONNECTED WITH PERSONAL DATA**

#### INTRODUCTORY INFORMATION

Please pay attention to the following document through which we provide you with information on the processing of your personal data and the rights related to the processing of your personal data by **Endowment fund of Jaroslav Tupý, ID 07291108, registered office Rozvojová 263, Lysolaje, 165 00 Praha 6, registered by the Municipal Court in Prague, file N 1624.**

Any handling of personal data is governed by applicable law, in particular Regulation 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46 / EC (hereinafter referred to as the "**General Regulation on Personal Data Protection**"). In accordance with the provisions of Article 13 and following of the General Regulation on Personal Data Protection, we provide you with the following information as so-called data subjects. This document is public and serves for your proper disclosure of the scope, purpose, timing of the processing of personal data, and information on your rights in connection with their protection.

#### WHO IS THE CONTROLLER OF PERSONAL DATA?

The controller of personal data is **Endowment fund of Jaroslav Tupý, ID 07291108, registered office Rozvojová 263, Lysolaje, 165 00 Praha 6, registered by the Municipal Court in Prague, file N 1624** (hereinafter referred to as „**Controller**“).

#### IN GENERAL – WHAT IS ALL BETWEEN PERSONAL DATA?

Personal data is any information relating to an identified or identifiable natural person (human) through whom a particular individual can be identified, directly or indirectly. Personal information includes a wide range of information such as name, gender, age and date of birth, personal status, photos (or any form of appearance), birth registration number, place of residence, telephone number, e-mail, health insurance (physical and psychological), but also fingerprint, signature or IP address.

#### BASED ON WHICH LEGAL BASIS WE PROCESS YOUR PERSONAL DATA?

We process the personal data stated because the processing is necessary for receiving a donation gift to the endowment fund.

#### SCOPE OF PERSONAL DATA PROCESSED BY THE CONTROLLER

We inform you that we process your personal data in this scope: name, surname, bank account.

#### PURPOSE OF PROCESSING PERSONAL DATA

The Controller processes and maintains, under the conditions and within the limits established by the applicable law, in particular in accordance with the provisions of Article 6 sec. 1 letter b) the General Regulation on Personal Data Protection, your personal data for these purposes:

- receipt of the donation gift to the endowment fund.

## TIME OF PROCESSING PERSONAL DATA

We will store your personal data for 5 years.

## ADDITIONAL INFORMATION ON PROCESSING PERSONAL DATA

Personal data of the data subject are processed manually and electronically in an automated manner.

We do not pass your personal data and we do not intend to transfer your personal data to a third country or international organization.

## EDIFICATION REGARDING RIGHTS OF DATA SUBJECT

The data subject has the right to withdraw the granted consent at any time, for example by sending a letter to the Controller: **Endowment fund of Jaroslav Tupý, ID 07291108, registered office Rozvojová 263, Lysolaje, 165 00 Praha 6, registered by the Municipal Court in Prague, file N 1624** or by e-mail: [nfjt@ueb.cas.cz](mailto:nfjt@ueb.cas.cz). In such case the controller terminates the processing of personal data on the basis of the consent of the data subject, e.g. in the concrete example by publishing on the website, but he will continue to process the personal data of the data subject in order to fulfill his contractual and statutory obligations as employer.

The data subject has the right to request the Controller to provide information about the processing of his or her personal data.

The data subject has the right to correct inaccurate personal data relating to him without undue delay. Taking into account the purposes of the processing the data subject has the right to supplement incomplete personal data including provision of an additional statement.

The data subject has the right to erasure of personal data concerning him or her without undue delay and the controller shall have the obligation to erase personal data without undue delay in cases stated by the General Regulation on Data Protection Regulation.

The data subject shall have the right to obtain from the controller restriction of processing in cases stated by the General Regulation on Personal Data Protection.

The data subject shall have the right to receive the personal data concerning him or her, which he or she has provided to a Controller, in a structured, commonly used and machine-readable format and have the right to transmit those data to another Controller without hindrance from the Controller to which the personal data have been provided in cases stated by the General Regulation on Personal Data Protection.

If the data subject considers that a legal violation has occurred in connection with the protection of his or her personal data, he has the right to file a complaint with the Office for personal data protection in the Czech Republic.
